

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to STEADFASTBEAUTY.COM/STEADFASTBEAUTYANDDESIGNS.COM, and STEADFAST BEAUTY + DESIGNS and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to STEADFAST BEAUTY + DESIGNS include

STEADFASTBEAUTY.COM/STEADFASTBEAUTYANDDESIGNS.COM, SB / STEADFAST BEAUTY, LORRAINE AMADOR and STEADFASTBEAUTY.COM. The SB / STEADFAST BEAUTY website is a SMALL BUSINESS/BEAUTY SERVICE/SALON RETAIL/CUSTOM DESIGNED MERCHANDISE/ECOMMERCE/DIGITAL MARKETING SALES site. By using the SB / STEADFAST BEAUTY website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, SB / STEADFAST BEAUTY may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase SB / STEADFAST BEAUTY's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

SB / STEADFAST BEAUTY may also collect anonymous demographic information, which is not unique to you, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us.
